

AMENDMENT TO THE AMENDMENT IN THE NATURE OF A SUBSTITUTE TO H.R. 3684 OFFERED BY MR. Stauber

Page 276, line 3, strike "and" at the end.

Page 270 after line 3, insert the following (and redesignate accordingly):

1 (D) by inserting "copper, nickel, cobalt, 2 platinum group elements, rare earth elements, 3 or other minerals extracted from within the 4 United States and insular territories," after 5 "iron,"; and

Page 390, line 5, strike the closing quotation mark and period at the end.

Page 390, after line 5, add the following:

- 6 "(f) CERTIFICATION.—The Secretary of Commerce
- 7 shall certify that no electric vehicle charging stations in-
- 8 stalled under this section use minerals sourced or proc-
- 9 essed with child labor, as such term is defined in Article

Page 453, line 6, strike the closing quotation mark and period at the end.

Page 45% after line 6, add the following:

"(11) CERTIFICATION.—The Secretary of Com-3 merce shall certify that no projects carried out under 4 this subsection use minerals sourced or processed 5 with child labor, as such term is defined in Article 6 3 of the International Labor/Organization Conven-7 tion concerning the prohibition and immediate action 8 for the elimination of the worst forms of child labor 9 or in violation of human (December 2, 2000), 10 11 rights.".

Page 801, line 5, strike "and" at the end.

Page 801, line 10, strike the period and closing quotation mark and insert "; and".

Page 801, after line 10, insert the following:

12 ((D) for which the recipient has certified 13 that at least 51 percent of critical mineral and 14 rare earth content in the buses were either do-15 mestically sourced or domestically sourced joint-

14	(a) IN GENERAL.—Subtitle III of title 49, United
15	States Code, is amended by adding at the end the fol-
16	lowing:

1	"CHAPTER 66—DOMESTIC PRODUCTION
2	OF ELECTRIC VEHICLES
3	"§ 6601. Task force
4	"(a) ESTABLISHMENT.—The Secretary of Transpor-
5	tation shall establish a Task Force to Promote American
6	Vehicle Competitiveness (hereinafter referred to as the
7	'Task Force') in accordance with this section.
8	"(b) Membership.—
9	"(1) In General.—The Task Force shall be
10	composed of the following officers:
11	"(A) The Secretary of Transportation.
12	"(B) The Secretary of the Interior.
13	"(C) The Secretary of Commerce.
14	"(D) The Secretary of Energy.
15	"(E) The Administrator of the Environ-
16	mental Protection Agency.
17	"(2) Additional members.—The Secretary
18	may designate additional members to serve on the
19	Task Force.
20	"(3) Officers.—The Secretary of Transpor-
21	tation shall serve as Chair and may designate offi-
22	cials to serve as the Vice Chair, and on any working
23	groups of the task force.
24	"(a) DrummaThe Task Force shall-

1	"(1) identify and resolve any jurisdictional or
2	regulatory gaps or inconsistencies associated with
3	domestic sourcing and production of electric vehicle
4	batteries to eliminate, so far as practicable, impedi-
5	ments to the prompt and safe deployment of domes-
6	tically produced electric vehicle batteries, including
7	with respect to safety regulation and oversight, envi-
8	ronmental review, and funding issues;
9	"(2) coordinate agency oversight of nontradi-
10	tional and emerging electric vehicle battery sourcing
11	and production technologies, projects, and engage-
12	ment with external stakeholders;
13	"(3) within applicable statutory authority other
14	than this subsection, develop, recommend, and estab-
15	lish processes, solutions, and best practices for iden-
16	tifying, managing, and resolving issues regarding do-
17	mestic sourcing and production of electric vehicle
18	batteries; and
19	"(4) carry out such additional duties as the
20	Secretary of Transportation may prescribe, to the
21	extend consistent with this title.
22	"(d) REPORT.—Not later than 12 months after the
23	date of enactment of this section, and annually thereafter,
24	the Task Force shall submit to the Committee on Trans-
25	portation and Infrastructure of the House of Representa-

1	tives and the Committee on the Environment and Public
2	Works of the Senate a report containing findings on elec-
3	tric vehicle battery sourcing and production issues in the
4	United States, recommended strategies or measures to
5	streamline sourcing and production and promote Amer-
6	ican competitiveness, and any recommended legislative so-
7	lutions.
8	"§ 6602. Critical mineral sourcing
9	"(a) In General.—The Secretary of Transpor-
0	tation, in conjunction with the Task Force to Promote
11	American Vehicle Competitiveness, shall coordinate with
12	the appropriate agencies to increase domestic sourcing of
13	critical minerals and domestic production of electric vehi-
14	cle batteries.
15	"(b) DEPARTMENT COORDINATION.—The Depart-
16	ment of Transportation shall coordinate with the Task
17	Force and prioritize accordingly when making awards
18	under section 5339(c) and sections 151, 155 of title 23.".
19	(b) Critical Mineral Sourcing.—
20	(1) SECTION 304 .—Section 304 of title 49,
21	United States Code, is amended—
22	(A) in the section heading by striking
23	"multimodal" and inserting "transpor-
24	tation or transportation-related crit-
25	ical mineral sourcing"; and

1	(B) in subsection (a)—
2	(i) in paragraph (1) by striking "De-
3	partment of Transportation operating ad-
4	ministration or secretarial office" and in-
5	serting "Federal agency"; and
6	(ii) by striking paragraphs (2) and (3)
7	and inserting the following:
8	(2) LEAD AGENCY.—The term 'lead agency'
9.	means a Federal agency, or State agency that has
10	been delegated authority under the National Envi-
11	ronmental Policy Act of 1969 (42 U.S.C. 4321 et
12	seq.), that has the lead responsibility for compliance
13	with such Act with respect to the proposed project.
14	"(8) MULTIMODAL PROJECT.—The term
15	'multimodal project' has the meaning given such
16	term in section 139(a) of title 23.".
17	(2) Section 139. Section 139(a)(5) of title
18	23, United States Code, is amended to read as fol-
19 '	lows:
20	"(5) MULTIMODAL PROJECT.—The term
21	'multimodal project' means a project that requires
22	the approval of more than I State department of
23	transportation operating, administration, or secre-
24	tarial office, or a project related to domestic
