Dear Majority Leader Schumer, Speaker Pelosi, Senate Republican Leader McConnell, and House Republican Leader McCarthy,

The Everglades Foundation works to restore and protect America's Everglades through science, advocacy, and education. We write to support the passage of the Water Resources Development Act (WRDA) of 2022. This legislation contains important water resource, natural infrastructure, and climate resilience policy for the United States Army Corps of Engineers (USACE). It is important that each Congress pass this historically bipartisan legislation, and the passage of WRDA 2022 would cap a decade of this important milestone. Fittingly, Everglades restoration enjoys historic bipartisan support and is a national example of restoration and natural infrastructure building resilience in areas facing daily threats from climate change. It was in WRDA 2000 that Congress authorized the Comprehensive Everglades Restoration Plan (CERP), a 50-50 cost shared program between the federal government and the State of Florida to "restore, preserve, and protect the South Florida ecosystem while providing for other water-related needs of the region, including water supply and flood protection."

Today, Everglades restoration is amidst tremendous momentum and supports numerous benefits, including inland and coastal flood protection, unmatched recreation, habitat and ecosystem protection, human and ecological resilience, drinking water security for millions, and serves as an economic driver for local, state, and national economies. As Everglades restoration serves as a banner example of America's ability to combat climate change, build resilience, enhance water infrastructure, and restore the environment, it is important that federal policies continue to evolve in these areas. The passage of WRDA 2022 will advance our nation's ability to address these issues through work implemented by USACE. Through whatever legislative vehicle is needed, we support the passage of this critical legislation.
