OFFERED BY MR. GRAVES OF LOUISIANA

At the end of subtitle E of title V of division B of the bill, add the following:

1	SEC TRANSPORTATION RESILIENCE AND ADAPTA-
2	TION CENTERS OF EXCELLENCE.
3	(a) IN GENERAL.—Chapter 5 of title 23, United
4	States Code, is further amended by adding at the end the
5	following:
6	"§52 Transportation resilience and adaptation
7	centers of excellence
8	"(a) DEFINITIONS.—In this section:
9	"(1) CENTER OF EXCELLENCE.—The term
10	'center of excellence' means a Center of Excellence
11	for Resilience and Adaptation designated under sub-
12	section (b).
13	"(2) ELIGIBLE ENTITY.—The term 'eligible en-
14	tity' means—
15	"(A) an institution of higher education (as
16	defined in section 102 of the Higher Education
17	Act of 1965 (20 U.S.C. 1002)); or
18	"(B) a consortium of nonprofit organiza-
19	tions led by an institution of higher education.

2 "(1) IN GENERAL.—The Secretary of Transpor-3 tation shall select 11 eligible entities to be des-4 ignated as centers of excellence and to receive grants 5 to advance research and development that improves 6 the resilience of surface transportation infrastruc-7 ture and infrastructure dependent on surface trans-8 portation to natural disasters and extreme weather. 9 ((2) Selection.—

10 "(A) REGIONAL CENTERS OF EXCEL-11 LENCE.—The Secretary shall designate 1 re-12 gional center of excellence in each of the 10 13 Federal regions described in the document ti-14 tled 'Standard Federal Regions' published by 15 the Office of Management and Budget and 16 dated April 1974 (circular A-105).

17 CENTER "(B) NATIONAL OF EXCEL-18 LENCE.—The Secretary shall designate 1 na-19 tional center of excellence to coordinate the ac-20 tivities of the 10 regional centers of excellence 21 described in subparagraph (A), minimize dupli-22 cation of activities, and promote coordination 23 and dissemination of research among such re-24 gional centers of excellence.

2	ignated as a center of excellence under paragraph
3	(1), an eligible entity shall submit to the Secretary
4	an application at such time, in such manner, and
5	containing such information as the Secretary may
6	require, including a proposal that includes a descrip-
7	tion of the activities to be carried out with a grant
8	under this section.
9	"(4) CRITERIA.—In selecting eligible entities to
10	designate as a center of excellence, the Secretary
11	shall consider—
12	"(A) the past experience and performance
13	of the eligible entity in carrying out activities
14	described in subsection (d);
15	"(B) the merits of the proposal of an eligi-
16	ble entity submitted under paragraph (3) and
17	the extent to which the proposal would—
18	"(i) advance the state of practice in
19	resilience planning and identify innovative
20	resilience solutions for transportation as-
21	sets and systems;

23	carried out by another Federal agency re-

20	priations, the Secretary shall provide to each center of ex-

22	less than $$5,000,000$ for each of fiscal years 2022 through
23	2031 to carry out the activities described in subsection

"(d) ELIGIBLE ACTIVITIES.—Funds made available
 under this section may be used by an eligible entity des ignated as a center of excellence under subsection (b) to
 establish and operate a center of excellence and for activi ties that promote resilient transportation infrastructure,
 including through—

"(1) supporting climate vulnerability assess-7 8 ments informed by climate change science, including 9 national climate assessments produced by the United 10 States Global Change Research Program under sec-11 tion 106 of the Global Change Research Act of 1990 12 (15 U.S.C. 2936), relevant feasibility analyses of re-13 silient transportation improvements, and transpor-14 tation resilience planning;

15 "(2) development of new design, operations,
16 and maintenance standards for transportation infra17 structure that can inform Federal and State decision
18 making;

"(3) research and development of new materials
and technologies that could be integrated into existing and new transportation infrastructure;

"(4) development, refinement, and piloting of
new and emerging resilience improvements and
strategies, including natural infrastructure approaches and relocation;

1	"(5) development of and investment in new ap-
2	proaches for facilitating meaningful engagement in
3	transportation decision making by local, Tribal, re-
4	gional, or national stakeholders and communities;
5	"(6) technical capacity building to facilitate the
6	ability of local, regional, Tribal, State, and national

8	"(A) assess the vulnerability of transpor-
9	tation infrastructure assets and systems;
10	"(B) develop community response strate-
11	gies;
12	"(C) meaningfully engage with community

3 "(e) FEDERAL SHARE.—The Federal share of the
4 cost of an activity carried out using a grant under this
5 section shall be 50 percent.".

6 (b) CLERICAL AMENDMENT.—The analysis for chap7 ter 5 of title 23, United States Code, is amended by add8 ing at the end the following new item:

"52__. Transportation resilience and adaptation centers of excellence.".
