10	"(a) Licenses and Certificates of Registry.—
11	Notwithstanding sections 7106 and 7107, the Secretary
12	of the department in which the Coast Guard is operating
13	may extend for up to one year an expiring license or cer-
14	tificate of registry issued for an individual under chapter
15	71 if the Secretary determines such extension is re-
16	quired—
17	"(1) to enable the Coast Guard to eliminate a
18	backlog in processing applications for those licenses
19	or certificates of registry:

1	"(2) because necessary records have been de-
2	stroyed or are unavailable due to a natural disaster;

4	"(3) to align the expiration date of a license or
5	certificate of registry with the expiration date of a
6	transportation worker identification credential (also
7	known as transportation security cards) under sec-

9	"(b) Merchant Mariner Documents.—Notwith-
10	standing section 7302(g), the Secretary may extend for
11	one year an expiring merchant mariner's document issued
