14	(8) Accessibility experts or advocates.
15	(9) Transportation engineers, planners and de-
16	signers in current practice.
17	(10) State departments of transportation.
18	(d) Priorities.—In carrying out the update re-
19	quired under subsection (a), the Secretary shall address
20	the following priorities:
21	(1) Protection of vulnerable road users (as de-
22	fined in section 148(a) of title 23, United States
23	Code).
24	(2) Prioritization of the safety of road users
25	over traffic speed or the free flow of traffic.

1	(3) Promotion of cycling, walking, and use of
2	public transportation.
3	(4) Incorporation of safety and sustainability
4	elements, including—
5	(A) protected, buffered, and counterflow
6	bike lanes, including green bike lanes;
7	(B) devices or markings used to protect
8	bike lanes, including delineator posts, bumps,
9	bollards, planters and curbs;
10	(C) bus lanes, including red bus lanes;
11	(D) marked crosswalks, regardless of traf-
12	fic volumes;
13	(E) walk signals, regardless of the number
14	of injuries or deaths at a given intersection;
15	(F) pedestrian Hybrid Beacons; and
16	(G) protected or "Dutch" intersections.
17	(5) Replacing the 85th percentile speed on all
18	streets or roads that are not part of the National
19	Highway System with the complete and context sen-
20	sitive street design required under section 1107 of
21	this Act.
22	(6) Providing approved alternatives to level of
23	service for motor vehicles only to facilitate the better
24	measurement of the performance of a facility cov-
25	ered by the MUTCD.

1	(e) APPLICABILITY OF MUTCD.—Pursuant to the
2	authority granted in section 109(c)(2) of title 23, United
3	States Code, and section 1107 of this Act, the Secretary
4	shall review the appropriateness of State design standards
5	being applied to city or municipal owned streets on the
6	National Highway System. As part of this review, the Sec-
7	retary shall consider—
8	(1) relieving States of their duty to separately
9	conduct design review of projects funded through the
10	Federal Highway Administration on city or munic-
11	ipal owned roads that have already received local ap-
12	proval;
13	(2) requiring that States defer to locally-adopt-
14	ed design standards in reviewing projects on all city-
15	owned streets;
16	(3) expediting interim approval for devices that
17	have succeeded in at least one experiment;
18	(4) allowing new uses of existing devices unless
19	explicitly prohibited elsewhere; and
20	(5) providing a vulnerable-user signal warrant
21	to cover all scenarios in which the Federal Highway
22	Administration has proposed to prohibit uncontrolled
23	crosswalks.
24	(f) Timing of Regular Updates.—Pursuant to
25	section 109 of title 23, United States Code, the Secretary

- 1 shall review its existing guidance for when updates to the
- 2 Manual on Uniform Traffic Control Devices occur and
- 3 make any adjustments to that guidance needed to ensure
- 4 the Secretary is timely updating the MUTCD to take into
- 5 account advances in design standards, road markings, and
- 6 traffic devices. The Secretary shall consider requiring that
- 7 the MUTCD be reviewed at least once every 4 years for
- 8 any necessary updates.
