

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 3684
OFFERED BY MISS GONZÁLEZ-COLÓN OF PUERTO
RICO**

Page 185, strike lines 7 through 12 and insert the following:

1 (5) TERRITORIAL HIGHWAY PROGRAM.—For
2 the territorial highway program under section 165 of
3 title 23, United States Code, the amount specified in
4 section 165(a) for each of fiscal years 2023 through
5 2026.

Page 198, line 3, strike “165(a)” and insert “subsections (a) and (b) of section 165”.

Page 226, line 3, strike “165(a)(1)” and insert “165(b)”.

Page 226, line 6, strike “165(a)(2)” and insert “165(a)”.

Page 343, strike lines 8 through 15 and insert the following:

1 (5) TERRITORIAL HIGHWAY PROGRAM.—Section
2 165(c)(6)(A)(i) of title 23, United States Code, is
3 amended by striking “block grant”.

Page 564, strike line 10 and all that follows through
page 566, line 13 and insert the following:

4 **SECTION 1501. TERRITORIAL AND PUERTO RICO HIGHWAY**
5 **PROGRAM.**

6 (a) IN GENERAL.—Section 165 of title 23, United
7 States Code, is amended—

8 (1) in the section heading by striking “**and**
9 **Puerto Rico**”; and

10 (2) by striking subsections (a) and (b) and in-
11 serting the following:

12 “(a) FUNDING.—Each territory eligible to receive
13 funds under subsection (c) shall receive an amount that
14 is equal to one-fifth of 1 percent of funds made available
15 under section 104(b).

16 “(b) APPORTIONMENT FOR PUERTO RICO.—The
17 Commonwealth of Puerto Rico shall be eligible to receive
18 funds apportioned under this title in the same manner as
19 a State receives such funds.”.

20 (b) DEFINITION OF STATE.—

21 (1) SAFETEA-LU.—Section 1120 of
22 SAFETEA-LU (23 U.S.C. 101 note) is amended by
23 striking subsection (c).

1 (2) TRANSPORTATION EQUITY ACT FOR THE
2 21ST CENTURY.—Section 1103 of the Transportation
3 Equity Act for the 21st Century (Public Law 105–
4 178) is amended by striking subsection (n).

5 (c) CLERICAL AMENDMENT.—The analysis for chap-
6 ter 1 of title 23, United States Code, is amended by strik-
7 ing the item related to section 165 and inserting the fol-
8 lowing:

“165. Territorial highway program.”
