## FEMA Communication Timeline Summary through November 1, 2024

9/26-9/27 Hurricane Helene hits Transylvania County

10/1- Phone call comes in to EM Director Kevin Shook saying that FEMA will be arriving hoping for the following afternoon.

10/2- No FEMA contact

10/3- No FEMA contact, reach out to federal offices to get contact information

10/4- Call contact referred by Edward's office Mike Cappanarri- referred to DJ Cessner as our contact- he referred to Denver Applehans as internal affairs contact. \*Note- explained need for individual assistance and housing concerns to Mike and DJ as I am passed to next person who is supposed to be assigned to my county.

Email with Denver Applehans our needs for individual assistance and to discuss housing/FEMA trailers.

10/5- Patrick Lake arrives and introduces self as FEMA coordinator for county. Staff share needs of temporary housing trailers and Individual Assistance. Patrick puts in a report with those requests and says he will update us on status of requests.

Dan Shulman (no contact with him prior) sends email that he will be replaced by Ricardo Zuniga as External Affairs

10/9- Allen Rahn comes unannounced to EOC as Internal Affairs contact (was Denver Applehans- no communication since 10/4) with Heather Long. No communication received since 10/4 email with Denver Applehans that the internal affairs contact has changed. They report to EOC and then leave to go meet with mayor after staff explain they need to talk to the county manager and that county is leading emergency effort. I return to EOC and call last known IA contact Denver Applehans who informs me he isn't my IA anymore and not the one in county at the moment. Receive call from Allen and direct for them to report to EOC ASAP. Explain to Allen Rahn and Heather Long that we need individual assistance and to start a process for temp housing because hotel vouchers aren't usable here and there are no rentals. They elevate questions on housing and let me know they will follow up if they get answers. Allen will be in Haywood 10/10. By end of day Heather confirms DSA teams will be at EOC at 8 am to go door to door.

10/9- Kyle Bridges from Senator Budd's office connects county manager to Ibrahim Hashi and copies Allen Renn regarding the 10/5 request for housing, critical issues of no hotels accepting vouchers and need for housing. County manager gets on call with Ibrahim and he promises to follow up. Kyle requests that Ibrahim assign someone on his team.

10/10- Ibrahim responds and assigns Allen Renn who has already told county staff the day before that he isn't sure who can help with housing but he will try to find out (No follow up received from Allen Renn) This is the first time elevating an issue results in being sent back in a circle to the first FEMA staff that cannot help.

10/10- 8 am two DSA teams arrive in Transylvania County. They tell county staff they were reassigned overnight to Transylvania County. Door to Door visits with DSA deploy with county staff. During briefing meeting explain to FEMA staff present the need for application assistance, in understanding denials for

those being denied and that hotel vouchers are not accepted here and there are no units for rent so temporary housing needs to be planned for as soon as possible.

10/10- 7 people from FEMA arrive to look at space proposed for a DRC. Keith B Snead, FEMA Disaster Safety Officer determines it meets the standards necessary and also tells assistant county manager that NCEM sets the priority for when a DRC opens and that an agreement will need to be signed once sent. This is the first that county staff is told NCEM makes that call. Previously Patrick Lake indicated he has made a request.

10/11- Door to Door visits with DSA deploy with county staff.

10/11- County Manager emails Keith Snead (FEMA) to inquire about DRC progress and agreement status (receives no response)

10/12- Patrick Lake calls and says the DSA teams have been sent back to a hotel. They had an uncomfortable situation at Turkey Pen Trailer Park where someone told them that FEMA wasn't welcome there and that there were some others standing around glaring at them. 15 minutes later the Rutherford County threat came in so they pulled everyone. I confirmed with Patrick that no threats were made in Transylvania.

10/14- Discuss the weekend situation with Patrick Lake and Heather Long. They indicate that DSA will not be going door to door. They work with county staff to plan a fixed location for DSA at the county library.

10/14- State EM representatives come to visit including Brian Barnes and Justin Graney. County staff explain ongoing frustrations with the delay of support coming to Transylvania County, mixed messages, communication and express needs around DRC and housing.

10/14- Assistant county manager sends a follow up regarding DRC request to Keith Snead via phone and was referred to Robert Jones. Robert Jones, FEMA logistics reported that he had just received request for DRC (Patrick Lake entered a request 10/5). Robert says that an agreement will be reviewed and sent for signature and is in the hands of the FEMA attorney for action. It will then go to State IA. Follow up with NCEM Justin Graney.

10/15 Transylvania County Sheriff Owenby receives contact from James Longanecker saying DSA teams will be going door to door. Sheriff and county staff discuss with Patrick Lake and he confirms that the DSA teams will not be going door to door. Later County Dispatch Receives a call from Kevin

10/15- *Stephanie Nash* IM CORE| Disaster Recovery Centers Group Supervisor| emails that DRC will set up and soft open on 10/17 and officially open 10/18 at Transylvania County Community Services Building. County IT and Operations are scheduled to support set up on 10/17.

10/15- Kevin Bowen calls Transylvania County Dispatch. He tells dispatcher that on 10/13 DSA team was in Transylvania County and reported racial tension and were approached by people with an AK47. Tells dispatch he wants to know "where black people shouldn't go without police escort". Sheriff Owenby receives a call from Kevin Bowen and states there was an incident of racial tension from Saturday.

10/16- DSA team is set up at fixed location at Transylvania County Library.

10/16- James Longanecker emails county manager Laughter that DSA teams will be going door to door today. Manager Laughter advises that is not the case and copies in Patrick Lake and Heather Long.

10/16- FEMA DRC staff show up at community services saying they are opening the DRC. They then tell county staff that their equipment and security went to Haywood County so they cannot open. FEMA representatives Patrick Lake and Heather long confirm they were not made aware the plan changed from what was received from Stephanie Nash the afternoon prior nor was county staff. Nash replies that the changes were made per senior leadership and references Cory Fast and Michaela Koverman.

10/16- County Manager Laughter gets a call from Tom Farrigon. Tom apologizes for all of the miscommunication and explains that due to short staffing many of the reps are actually from other federal agencies and functions where this is not their normal duties. Says the mix up about DSA going door to door was because someone was trying to be helpful and it had been addressed. Manager Laughter advises on dispatch call and Tom requests screenshots and the name of the worker so he can follow up. She sends the CAD report and name via text following the call.

10/17- Sheriff receives a call from Kevin \_\_\_\_ (2025773092) telling him that DSA will be going door to door. Sheriff confirms with county manager that the DSA teams are not scheduled to be going door to door and the DRC has been set up. Sheriff then receives a call from Kevin Bowen complaining to him that he got jumped all over for this racial tension call and telling him it is the report he received. Sheriff Owenby reiterates the issue of calling dispatch four days after the incident with a very different description of what happened and that the call recorded on CAD was inappropriate.

10/17- Congressman Edward's office confers with Cole Baker, FEMA liaison about questions on housing options and process. He refers back to Heather Long. Heather has been in Transylvania County since 10/9 and has been unable to get answers to the housing questions as well. This is the second time an elevated question has been referred back to a FEMA person on site who has already not been able to answer or get answers themselves. Patrick Lake is being replaced by Monica Balik. Late on 10/17 a meeting is scheduled for 10/18 to talk about housing.

10/18- Meeting with Monica Balik and Heather Long from FEMA. FEMA representatives from housing are here and answer questions on process and options citizens will have. Brenda Morris from NCEM is also present. Housing reps from FEMA include: Julia Moline, Nicole Dunne and Matthias Mandigo. This was a very positive meeting. Brenda Morris says case management has been requested for Transylvania County. Kevin Caulfield (sp?) from FEMA Security calls Sheriff Owenby saying that staff will be canvassing door to door. Heather Long confirms to county manager that is not accurate and says she and Monica will elevate the miscommunication issue. Start planning for a housing speakers bureau (housing presentation) for 10/28.

10/18 (maybe earlier?)- County makes Debris removal request for USACE into NCEM as instructed.

10/22 Sheriff receives another call from Kevin Caulfield, FEMA security saying that teams are canvassing door to door. Confirm with Monica Balik and Heather Long that this is not happening and make them aware that the miscommunication continues.

10/22 Have a hand off meeting from Heather Long as intergovernmental affairs to Tom Hardy and Mark Barlett. Heather provides written report at hand off to assist. Go over communication issues that persist, outstanding support requests, housing concerns and actions taken to date. Tom provides some guidance that has already been utilized by both county representatives and local FEMA representatives including Patrick Lake, Monica Balik and Heather Long. Tom and Mark will be covering multiple counties and indicated with 6 counties they may not be able to be present even once a week. Monica Balik remains. Sheriff is still receiving calls from DC stating that representatives are going door to door but they are not. Heather lets Monica, Tom and Mark know they have tried to address this internally and it keeps happening.

10/22- Request update on outstanding housing elements discussed on 10/18 from NCEM Brenda Morris, and FEMA reps Julie Molin, Nicole Dunne and Matthias Mandigo. Julie Molin replies that follow up will come.

10/22 Send in 2 possible congregate FEMA sites to the email address provided by FEMA Housing Logistics including Davidson River Campground (Federal Asset)

10/23- NCEM Brenda Morris follows up on 3 out of 5 of the items with updates.

10/23- Monica Balik provides a morning sit report- very helpful.

10/24- Meeting with USACE (Tony) about debris removal. Told that they can provide debris removal on private property as long as there is a Right of Entry form. County staff reach out to HOAs who have required to let them know that the request has been made and waiting on approval, but will need Right of Entry Form.

10/25- Get confirmation that housing representatives will be here Monday to present as requested 10/18 and push out notice on social media for Monday.

10/28- FEMA housing logistics (Julia Molin, Matthias Mandigo) provide public meeting presentation at county request on housing options (recorded and available on county website). They go over the possible options for FEMA housing such as rental assistance, RVs and Mobile Units. They confirm that Sunset Hotel in the county is now accepting vouchers but may be full. They also share that there are mobile units staged in Hickory. When asked, they state none have been assigned in the county but that they hope to have housing in place by the holidays. They share that the fair market rent increase request is in DC for consideration. NCEM (Brenda Morris) shares that case management has been approved and they are also trying to acquire units for survivors. Approximately 500 property owners have registered with FEMA with interest in the direct lease program in the region.

10/29- Connect county employee, Sarah Bracken with NCEM Brenda Morris and request assistance for her. She is in floodway and will need mitigation program, but assistance on that front is not scheduled until 11/11 per FEMA DRC.

10/30- County staff meet with Nicole Fresard with USACE and she tells them there is not approval for debris removal on private property.

10/30 Confirmation from Yevon Adams, NCEM that a camper has been secured for Sarah Bracken with delivery Monday.

10/31- Handover meeting from Monica to Howard Johnson, FEMA, along with USACE handover representatives going from Nicole to Jennifer. Discuss the discrepancy with debris removal guidance and communication issue but no answer other than they do not know why Tony gave prior guidance and that they can only communicate what they know. They do not know the status of debris removal request and say it isn't showing in their system and that it is up to state NCEM and nothing they can do. Ask what coordination is happening between FEMA and the numbers approved for housing that Monica is showing with NCEM that seems to be securing some units per Sarah Bracken situation day prior. FEMA reps do not know for sure. Request Howard to find out what he can and find out if the units in Hickory are any closer to moving out to serve. Also ask him to follow up on FMR request.

11/1- Follow up with NCEM on debris removal. They say that they are working on the request, but we also have to submit the request through the FEMA portal before we can be approved. This is the first time we have been told about this step. Staff submit through the FEMA portal as instructed.

I assure you that DSA is not going door to door today and FEMA reps here on the ground indicated Monday and yesterday that they were not going to be going door to door and tasked us with creating a fixed site for today for the DSA teams to operate. The DSA team is operating out of our library today from 12-8 at a fixed site.

I do want to express my frustration at the lack of coordination amongst different segments of FEMA. We are receiving contradictory information in our local team from different sources within FEMA and the lack of organization and coordination on the part of FEMA is failing my community and making the monumental task we have locally to support recovery in Transylvania County harder.

Our community deserves better.

You are both well aware of the struggles we have had with FEMA communication. This thread is where we were asking questions about a total loss determination of a county building by the City of Brevard and had submitted proof of any repairs vs the building assessed value as is allowed under the City ordinance to challenge a significant damage assessment. The City Planner followed up with NCEM and FEMA with some questions related to the NFIP. All of that is fine- what I take exemption to is Mr. Frye- a representative of FEMA- and his statement about the county highlighted in the string below implying the county is asking to be treated any differently than others. This is another situation where FEMA representatives are involved in creating tensions between us and our local partners which is not helping.

The County or I is not and has never asked to be treated differently than the other structures you have assessed. However, I did follow the advice of Katherine and get a licensed contractor to inspect the structures, and it is his opinion that there was no water intrusion other than the block basement of the larger building. I have provided an aerial from the aftermath that supports that conclusion.



- I. **TITLE:** Addendum to Guidelines for States and Communities on Emergency Work for the Replacement of Private Roads and Bridges for DR-4827-NC.
  - II. **DATE OF ISSUANCE:** February 12, 2025
  - III. **ADDENDUM STATEMENT:** This addendum provides clarifying information to the disaster specific guidance (DSG) issued on February 4, 2025, on emergency work for the replacement of private roads and bridges for DR-4827-NC.
  - IV. **ADDENDUM DETAILS:** The State of North Carolina will conduct hydrologic and hydraulic analyses to restudy and map all effective floodplains identified on the Flood Insurance Rate Map through FEMA's Cooperating Technical Partners program for rivers/streams affected by the replacement of private bridges/culverts once all replacements have been completed to ensure compliance with 44 CFR 60.3.

The State of North Carolina identified an inventory of private roads and bridges that may need emergency work and repair. North Carolina communities electing to utilize this DSG shall maintain permanent records for each bridge/culvert repair/replacement identified, including at a minimum:

- Permit application and permit. All applications and permits must be dated.
- Bridge/culvert design plans certified (sealed, signed, and dated) by a Professional Engineer licensed in the State of North Carolina demonstrating that the newly designed and installed private bridge/culvert provides conveyance greater than or equal to the original destroyed crossing.
- Location (latitude and longitude in decimal degrees to six decimal places) of the replacement bridge/culvert.

This DSG shall not apply to floodway/non-encroachment area violations identified by a community prior to the incident period for Tropical Storm Helene (September 25, 2024, to December 18, 2024) and cannot be used to remedy those violations.

- V. PERMIT TIMING AND EXTENSION PROCESS:** The permit for emergency work for these private roads and bridges may be issued beyond 180 days provided they were previously identified by the State within 180-days from the date of the DSG.

For example, the DSG was issued on February 4, 2025. If a permit for emergency work comes in after August 3, 2025, and they were previously identified for emergency work, then they would be allowed to obtain the permit.

The emergency permit may be extended beyond 180 days, in 90-day increments. The applicant may request an extension through the local community for approval.

The Federal Emergency Management Agency (FEMA) issued Disaster Specific Guidance (DSG) for emergency work for the replacement of Private Roads and Bridges (PRB) in Special Flood Hazard Areas (SFHAs) for communities within the declared area for FEMA-4827-DR-NC (Tropical Storm Helene). This memorandum provides further explanation for communities that elect to utilize this DSG and its Addendum.

Pursuant to this guidance, communities are not required to obtain, review, or approve a hydrologic or hydraulic analysis demonstrating no cumulative increase of the water surface elevation more than a designated height (no-rise studies), in accordance with 44 CFR 60.3(d)(3), prior to issuance of an emergency permit for the repair or replacement of PRB.

North Carolina Emergency Management (NCEM) will conduct hydrologic and hydraulic analyses to restudy and map all effective floodplains identified on the Flood Insurance Rate Map through FEMA's Cooperating Technical Partners program for rivers/streams affected by the replacement of private bridges/culverts once all replacements have been completed to ensure compliance with 44 CFR 60.3(d).

To be eligible for permitting pursuant to this guidance, communities must:

- Identify PRB damaged or destroyed by Tropical Storm Helene to be permitted by 3 August 2025 (within 180 days of 4 February 2025) and provide coordinates (decimal degrees to six decimal places) to [NCEMPRBDocuments@ncdps.gov](mailto:NCEMPRBDocuments@ncdps.gov). The permit does not have to be issued by this date.
- Receive a dated permit application. The permit application must include:

- Bridge/culvert design plans certified (sealed, signed, and dated) by a Professional Engineer licensed in the State of North Carolina demonstrating that the newly designed and installed private bridge/culvert provides conveyance greater than or equal to the original destroyed crossing.
- Issue a dated permit for replacement work. The length of the construction permit shall be per local rules and regulations and may be extended in 90 day increments as needed to complete the construction. The applicant will request any extension through the local community for approval. All construction must be completed no later than 26 September 2026.
- Provide a copy of the certified design plans and permit to [NCEMPRBDocuments@ncdps.gov](mailto:NCEMPRBDocuments@ncdps.gov).
- Maintain permit files as required under the National Flood Insurance Program (NFIP). The permit file for each bridge replaced should include a copy of the DSG, the DSG Addendum, and this memorandum.

The DSG does not apply to floodway/non-encroachment area violations identified by a community prior to the incident period for Tropical Storm Helene (25 September 2024 to 18 December 2024) and cannot be used to remedy those violations.

The DSG does not apply to new construction or site development unrelated to recovery efforts for Tropical Storm Helene (FEMA-4827-DR-NC), nor does it apply to communities outside the federally declared area for this disaster.

Projects permitted and constructed in accordance with this DSG, including maintaining permanent records, will not require no-rise studies to be performed for bridges replaced prior to NCEM completing and updating current Flood Insurance Rate Maps (FIRM) impacted by the work. Projects completed outside of this DSG or after FIRM updates are completed will continue to be subject to the requirements of the local Flood Damage Prevention Ordinance and NFIP regulations.

Use of this DSG will continue until such time that FEMA and NCEM determine that all PRB repair and replacement projects have been adequately addressed. The need to continue this DSG will be evaluated on an annual basis by FEMA and NCEM.

Since that is highlighted as the short term solution, the next question raised will be the one I have been asking- what short term solution is there available for Transylvania County?

The messaging is correct information on the tools at hand, but it is saying we are getting a hammer when all we have here are screws. Is there any plan to address this? The messaging is identifying solutions that are not realistic to apply here and could be seen as a false claim for those dealing with those realities in Transylvania County. ### FEMA Supporting Helene Survivors with Temporary Sheltering and Housing Solutions

RALEIGH, N.C. — FEMA and the state of North Carolina are working to ensure that survivors of Tropical Storm Helene are in safe, functional housing as the holiday season nears. Reimbursement for out-of-pocket hotel costs, financial assistance towards rent and home repair and FEMA-provided temporary hotel or motel stays are currently being provided to eligible households.

Additionally, at the request of the state of North Carolina, FEMA is providing Direct Temporary Housing Assistance to survivors displaced by Tropical Storm Helene. Qualifying households are eligible for temporary housing in 25 counties: **Alexander, Alleghany, Ashe, Avery, Buncombe, Burke, Caldwell, Catawba, Clay, Cleveland, Gaston, Haywood, Henderson, Jackson, Lincoln, Macon, Madison, McDowell, Mitchell, Polk, Rutherford, Transylvania, Watauga, Wilkes and Yancey.**

Direct Temporary Housing Assistance may be provided in three forms:

- **Direct Lease** - FEMA may lease existing, ready-to-occupy residential properties for use as temporary housing.
- **Multifamily Lease and Repair** - FEMA funds the repair or improvement of existing vacant multi-family rental properties that eligible applicants can use for temporary housing.
- **Transportable Temporary Housing** - A travel trailer or Manufactured Housing Unit (MHU) that FEMA may place on a private site or in a commercial park.

Direct temporary housing solutions are tailored to meet each households' individual needs and will take time. This assistance is not intended as an immediate solution for a survivor's shorter-term housing needs. Additionally, not everyone impacted by the disaster will be eligible for direct housing.

For survivors who need immediate shelter, financial assistance is available, including temporary lodging reimbursement, FEMA-provided hotel or motel stays or help with rent. These options remain FEMA's primary means of helping survivors.

Survivors who have applied with FEMA for assistance do not need to reapply to be eligible for Direct Temporary Housing Assistance. FEMA will contact households who may qualify after receiving their application for disaster assistance.

Hi, Tom! I was aware of the webinar and we pushed it out on our social media. The problem is that we don't have that kind of stock. Unless the air b and bs wanted to opt in one by one and take less revenue we are still without a short term solution. I am concerned the sentiment towards fema will be negatively impacted by telling survivors they have a solution for short term housing that they then find is not useable to them here. We have been trying to raise this concern since at least October 5. We have had citizens approved for vouchers they could not use without moving out of area. They have expressed feeling like they are being offered a paper solution and not a real one.

Heather- I wanted to make you aware of this. I have not talked to John Mitchell in Henderson to see if they are seeing these issues as well yet. I know just recently that hotel rooms accepting FEMA popped up in North Buncombe as the closest and prior to that it was Charlotte and Greenville, SC. The lack of available rentals that meet fair market rent is the other challenge. Our fair market rent rate is artificially low compared to the real market. We have challenged the FMR in the past because it always shows Transylvania lower than Buncombe and the reality is opposite, but HUD does not conduct surveys outside of the metro areas. We worked through Mark Meadows office years ago on that issue and did not get any traction to have the methodology changed, but knowing they will use that to set the rents means the units that are available will require survivors to come out of pocket for the remainder.

Hi Jaime,

I checked in with NCEM on the status of increasing the Fair Market Rent and here's their response:

"NCEM has requested to increase fair market rent to FEMA by 200% to help provide additional options in Western NC. Additionally, we are working with FEMA to move the Non Congregate Housing program forward which may allow additional flexibility in long term rentals. We recognize the housing challenge in Western NC did not begin with TS Helene but has been exceptionally exacerbated by the situation and we are working with FEMA and other non-profit partners to find ways to ensure survivors can locate disaster housing options as close to their community as possible."

I would normally summarize the response, but I felt their full statement helps provide additional context on what they are doing. I have now made the request through FEMA to approve the increase by 200% and will be talking with Rep. Edwards tomorrow morning on sending a delegation letter in support of NCEM's request.

Heather- I wanted to make you aware of this. I have not talked to John Mitchell in Henderson to see if they are seeing these issues as well yet. I know just recently that hotel rooms accepting FEMA popped up in North Buncombe as the closest and prior to that it was Charlotte and Greenville, SC. The lack of available rentals that meet fair market rent is the other challenge. Our fair market rent rate is artificially low compared to the real market. We have challenged the FMR in the past because it always shows Transylvania lower than Buncombe and the reality is opposite, but HUD does not conduct surveys outside of the metro areas. We worked through Mark Meadows office years ago on that issue and did not get any traction to have the methodology changed, but knowing they will use that to set the rents means the units that are available will require survivors to come out of pocket for the remainder.

There is still concern that there is not a plan for the short term since the FEMA vouchers do not work in our county and there are not rentals available at the fair market rent rate. There are air b and b's out there, but the rental price will be significant for a family to make work if all they receive if the FMR rate. Since that is highlighted as the short term solution, the next question raised will be the one I have been asking- what short term solution is there available for Transylvania County?

The messaging is correct information on the tools at hand, but it is saying we are getting a hammer when all we have here are screws. Is there any plan to address this? The messaging is identifying solutions that are not realistic to apply here and could be seen as a false claim for those dealing with those realities in Transylvania County. We have requested an increase in FMR through NCEM and we have explained the voucher issue, but I am interested in working with you on this concern so that there is a short term solution for the families in our community.

Tommy,

The timeline attached is lengthy and a work in progress as I sort through all my notes, emails and texts, but are some summary points:

- 1) FEMA wasn't here at all in our county for over a week.
- 2) FEMA reps who could help individuals apply were not here until day 12 after the storm and only after I completely lost my mind on a FEMA representative (I called chuck before I did that). It was another week before a DRC was set up here.
- 3) Twice I have elevated questions that couldn't be answered only to get looped back to the original person who couldn't answer my question.
- 4) We have had repeated situations of mixed messages. IE- our Sheriff getting calls that agents were going door to door while telling me they would not go door to door anymore (went on like this over a week with us raising the mixed messages as an issue the entire time). USACE guidance on debris removal parameters is another example as is how to make requests. Get told to do one thing to make a request only to wait and find out later we had to do something else that was never disclosed.
- 5) We had a delay in getting our households signed up for help because of the delay in getting FEMA in county. They are now processing and there are households identified for eligible for units. Last Monday we were told there are units in Hickory, but no units are showing up.
- 6) Housing tools typical with FEMA on the short term basis are problematic for our community. Just last week we finally had a (small) hotel locally start accepting FEMA vouchers. Otherwise they are having to go significant out of county to use them. Also, they use fair market rent to determine rental assistance. The FMR has been something we have commented on for HUD since 2018 that it is artificially low for us. We have requested an increase in that and it has been two weeks waiting for an answer. Without it, the rental assistance is futile. For congregate sites, we have been asking about the ability for them to use Davidson River Campground (federal asset) since Oct 5 when first FEMA rep arrived. We have submitted the request in three different ways as instructed at three separate times.

Howard,

I am copying in Julia Moline and Matthias Mandigo. They presented last Monday at the request of your predecessor, Monica Balik. She was at the meeting along with some representatives from the DRC as well. That is where it was said that the FMR increase up to 200% had been submitted and was under consideration and also that there are units in Hickory being staged. The question came up there and has continued since why we have units in Hickory and people qualifying, but still don't have timeline on when those units may be delivered to begin use.

Also, I was made aware that DSA teams were again going door to door this weekend. Is this accurate? In our meeting Thursday we talked about how it would not be helpful given that the DSA teams can only process applications and that it is frustrating people because they really need the higher level assistance at the DRC at this stage. Can you confirm what is happening? We are also getting reports of Red Cross going to private property and taking photos saying they are doing damage assessments, but there has been no check in with us at the EOC of that activity. I am following up with them on that matter, but if you have any information please let me know. The reports we have are that they are ignoring no trespassing signs and not following NC law in regards to entry on private property. We have completed our damage assessments and FEMA inspectors have already started responding to applicants.

Hi, Howard! We are aware of this resource and pushed it out on our county social media already. Monday the FEMA housing logistics folks said that we have had about 500 properties register, but we do not have an update on whether that has resulted in any of our households with need getting into units. Can you get an update on that?

Additionally, here are some other updates that would be helpful to have:

1. We initially submitted a request for the fair market rent rate to be increased by 200% October 22. Monday the FEMA representatives said that the request was being considered in DC. Any update?
2. Monday's presentation also included that there are units staged in Hickory. When asked when those would actually get distributed, the statement was that they hoped to have people in housing by the holidays. Monica from FEMA's email earlier this week showed we had 6 to be considered for travel trailers or mobile units and 3 that were staying in their flooded homes. Can we get a progress update on whether those 6 are receiving units and when? Now that they have made progress through the process and units are available in the state, it would be great to see them actually start getting set up before the cold sets in.
3. We submitted a debris removal request for US Army Corps support into NCEM about two weeks ago. Last week we were told by the USACE representative in a meeting with Monica that they could remove debris from private property with right of entry forms signed. We started communicating with our HOAs interested in assistance that this was requested and waiting for a decision, but then the USACE representative yesterday when we met for your changeover from Monica said that they are only authorized to clear out of the public right of way. We had included in our request that we wanted debris removal from the rivers because of the large number of trees in the riverways from the flood and removal will help future floods keep from creating additional damage. Access to those sites will more often than not be on public right of way. The USACE and FEMA reps yesterday in our meeting encouraged us to reach out to NCEM because the decision rests with them. We followed up there today only to find that we are also supposed to enter a request into a FEMA portal as well. We have now followed that instruction as well and would like any updates on whether we will get approved for USACE support for debris removal and if that will have any possibility of assisting on private property in addition to the stream clearing of logs.
4. Any updates on how many applications from our county, how many approved for housing and status there?



Here is an explanation of some of the housing numbers I have seen. My team created a database to work on the households that reached out to local housing assistance corp, habitat and our county staff saying they needed housing and that one had almost 40 last time I checked. We put the spreadsheet together locally to supplement coordination while NCEM is hiring the case manager we have been approved for (hiring is taking a long time).

What I see in our numbers is that very few are getting to the stage of rental assistance or qualifying for a unit to be placed. I have not been able to get anything (and have tried multiple times) that explains whether the low numbers are a product of application processing time, denials or people not applying. Here is what I do know from the last update I could get:

\*Two weeks ago I was told by a housing representative that has now been reassigned that our county had 6 who were approved for rental assistance and one for a unit that was supposed to be placed a week and a half ago. The IA report I received early last week only showed 3 getting rental assistance. I was told that is because some have qualified, but FEMA is waiting on them to confirm they are ready to accept and use them. I have followed up three times to see if the unit was placed and cannot get an answer.

\*The last IA report I have is from a week ago and it shows numbers that do not make sense overall. The number of people registered and eligible for Transitional shelter vs the ones showing as receiving it are dramatically different:

4,512 Total Registrations for Pennsylvania

For housing, 80 report emergent needs, 696 short term needs and 3,684 are currently housed  
For Transitional Housing assistance, 3,337 were eligible and 3,308 are eligible for the extended period, but only 58 cumulative have checked in to hotels.

For housing assistance, 214 qualify for repair or replacement, but only 3 were receiving rental assistance, 0 showing with direct housing and 6 in a waiting period. I will forward you those two emails showing the reports.

In county, between HAC (8 units) and Habitat (7 units) we have 15 RVs placed. There is another one that NCEM got through Baptist Housing Mission so our local effort to help with the housing needs is being more effective.

We have done what we can locally but the lack of coordination at state and federal with our local effort is a problem that we hope case management can bridge. We have shared with Ncem and fema a spreadsheet of needs we know about locally that we have been working off of and it is a live hosted spreadsheet. We have been told we can't get any information to cross reference our list and what is happening with household assistance.

I am incredibly disappointed at the lack of communication, organization and progress from our state and federal partners as is our local elected leaders and community partners. The frustration continues to grow.

You are maybe the 20th person I have had to update with this information so I apologize if this seems harsh, but rotating responsibilities and no accountability to follow up is exactly why progress seems minimal.

I was unable to get the depth of detail until this morning. Excuse the delay.

Based on FEMA data, these are the answers to your questions.

1. We submitted three sites for review for placement of trailers. Have these been assessed yet?

Two of those sites have been evaluated. These are the findings:

Lower Browns is feasible to put 12 RV pads Harris Mobile Home Park has potential for 4 Mobile Home Units to be placed there. It is in what is called "soft feasible." The site for the one MHU pad at The Spruce Pine Storage & Apartment has not been evaluated. These properties have not moved to the contracting queue. Negotiations may still be underway between the owner and the FEMA Contracting Representative.

2. Last week the report was 6 waiting for rental assistance and 1 trailer that was hoped to be placed last Thursday. Did the trailer get placed? How many are approved for rental assistance and how many in the pipeline?

Currently, per FEMA IA, there are 20 Rental Resources listed for Transylvania. Six households have been approved for FEMA's Direct Housing. One of the Households is awaiting for an inspection to be completed on their private site. The other five are awaiting assignments to commercial parks. Those survivors can request rental assistance from FEMA. They will need to provide a lease agreement to show the expense. Based on a 11/26/24 FEMA Housing Assistance Report, 11 Households have received rental assistance this far.

3. We had one RV that was assigned through NCEM that came from the Baptist Housing Mission. Have any more come through in Transylvania?

Unfortunately, I do not have visibility on Baptist Home Mission data.

You also asked the status of North Carolina Disaster Case Management.

Hiring has begun for North Carolina Disaster Case Managers. In the meantime, I have also been extremely encouraged by the counties that have already begun some version of local case management to get ahead of the curve.

County Manager:

Below are approximate meeting dates and inconsistent information I have received since applying for FEMA Public Assistance. I will attach any backup I can find on any of these items. Some of the Power Points attached are examples of the types of notes taken during our meetings with FEMA representatives.

During initial meetings with our PDMG (Exploratory Call on 11/13/24 & Recovery Scoping Meeting on 12/12/24) we were instructed to track every outcome that was a result of the storm. During the Recovery Scoping we were told we could not apply for reimbursement of lost revenue, however if we were covering the costs for the residents (ie: tipping/scale fees at the landfill) then that would be applicable. We were also instructed to apply for everything we could think of and if FEMA deemed it ineligible they would deny the claim and we would know we tried for everything we could.

At that time we began charging all storm related debris to the County account at the landfill during initial cleanup for the safety of the public. Then when we turned in our Cat A & Cat B breakdown for expedited funding, we were told by the same PDMG the scale fees the county was covering was considered lost revenue. I explained how our Landfill is an Enterprise fund and operates as a business, and the landfill would be sending a bill for the \$92,000 to the county and the county would pay the bill to the landfill. So this will be an expense to the County's general fund. There has been no confirmation on whether or not the \$92,000+ will be an allowable expense in our reimbursement claim.

At the Recovery Scoping Meeting we set a meeting schedule which was almost immediately changed when the recurring meeting invite was sent out. There have been many changes in the schedule, meeting locations and last minute cancellations since January. The lack of meeting communication is frustrating on our end because of other County obligations. When the meetings do occur and we asked questions, the questions were added to the power point in which the PDMG uses to take notes, but we have not received any confirmed answers to our questions, other than the change in original information that we cannot claim landfill fees for Debris Removal Cat A claims.

We did not charge FEMA or Red Cross rent on any of our properties used for shelters or DRC locations because staff recalled being told during a meeting the County would be able to claim dates of use and be reimbursed per square foot for the space used. This would offset utilities and programs that had to be cancelled from those locations. After the DRC closed and all shelters closed, we added this information to our Cat B expenses and were then told this was not reimbursable. We were told by PDMG we should have created a rental agreement with FEMA and Red Cross before they moved into those

spaces in order to recoup the cost to our operations. There is no reimbursable claim for our facilities being inaccessible to regular entities renting space or programs that had to be cancelled.

On February 13<sup>th</sup> during our PDMG meeting we reviewed the breakdown I created for the Cat A & Cat B expedited funding. The PDMG had concerns about the classification of some items listed so I created an updated list and sent it to her. At the next meeting on February 20<sup>th</sup> she provided a tentative total for our expedited funding but used the old list and took our everything that I had reclassified the prior week. On February 20<sup>th</sup> I resent the correct information to her. I have since received several drafts of the expedited funding, was told I needed to sign, then immediately after told it needed revisions and to not sign yet. We still do not have confirmation of expedited funding for our Cat A & Cat B expenses.


During a meeting with our Debris Removal group from USACE and NCEM on 1/31/25 where the PDMG was present, they stated they would be hosting bi-weekly meetings on the same days of our already scheduled meeting. During that meeting the PDMG told me in front of 5 other County staff that we could combine our meetings into that one to consolidate time spent, however the following week when I asked her if she would be recalling the meeting invite off calendars, she told me she never said anything about combining meeting times. I double checked with other staff at the meeting on 1/31/25 and they all heard the same thing.

The inconsistency of information has been beyond frustrating in this entire process. We ask questions, trying to work within the guidelines, receive guidance on what we need to do, we complete that, then are told it doesn't qualify and we will not get reimbursed. The amount of misinformation that is given verbally with no follow up in writing to confirm is frustrating in a field where public record, following guidelines and tracking information is key to ensuring everyone is on the same page.

Here is the updated list I had sent during our meeting last week that addresses splitting out the Cat A and Cat B projects that you mentioned in the email you just sent. This should be the accurate split out to review. And my current working document has the loss of revenue that we were told during our first meetings that would likely be reimbursable if we were paying the costs as a county. The Scale fees were applied to the County Solid Waste account that we paid to cover all storm debris after the storm. 

Good morning Bernard,

Back when the disaster was first declared and we knew there would be applications filed, we (County staff) were under the assumption that Fire Departments could be sub-recipients of the County and we could take care of their application for them. I confirmed with several other County Finance Officers across the state that they had handled it that way.

However, before we met with the fire departments on 10/22 I asked Monica Bilik, who was my point of contact at the time, about our options for filing and sub-recipients. Her responses are in the attached email. One answer seemed conflicting:  
“Generally, if an applicant is a separate entity they would need to be their own PA applicant. In your case, yes, each Fire Department would be a subscriber.”

So, I asked for confirmation one way or the other and received this:

“Clarification from Public Assistance: If the fire departments are separate legal entities they would need to be their own applicants for PA. The County could potentially help them in this process, but they would need to be on their own.”

Can you please let me know which is the correct answer so we will know for sure moving forward or if anything of this magnitude occurs again, we will know how we can help.

Apologies for the delayed response, Thank you for putting me in the email. I will be the main POC for the county public assistance for Hurricane Helene.

FYSA: Public assistance is currently working 7 days a week. 0700-1900 on weekdays 0700 to 1700 on weekends. Please reach out for any questions or assistance

Just to add a couple points:

- With the force account vehicles, let FEMA ask the question if they need more info. if its been used for the entire day we'll call it 24 hours. (stand by time can be included if equipment is used intermittently for more than half the working day) Or we could match it to the hours of the assigned personnel on that date on the payroll if we need.
- For Force account labor: OT only if for budgeted employees, if any of you had to get unbudgeted staff then straight and OT for them is eligible.
- If you had before/after pics of any damaged vehicles or equipment, we will want it but we understand "before" pics may not be available
- Time you spent staging assets and resources (labor and equipment) can be eligible, make sure to include that.
- Did any of you receive facility damages?

Regarding the submissions of the request for public assistance, (RPA) I've had a chance to go this over with a couple of you, so also sharing it here

- Attached is the briefing that was being shared to give you overview of the process
- If not sure you have an account or not I can check for you
- Below is a link to an older tutorial from FEMA, generally the same with some differences in the way it looks hopefully this helps as well.

Lastly, I and a team of PA staff will be staging in Dillsboro in Jackson county on Monday to coordinate with local and FEMA staff. From here we will make ourselves available to go out to meet with local towns/cities and PNP/Houses of worship, basically whoever that can be a potential applicant for the Public Assistance program.

I could potentially set a time to meet with all of you as needed. I would also like to ask for your help in spreading the word out as we navigate through the process, to the local churches and other houses of worship or eligible PNPs that may qualify for PA funding.

Hi Everyone,

I've copied in Bernard So with his permission, our FEMA representative. Mr. So - for your reference, this email thread is Transylvania County EM + Chiefs. He just helped answer several questions for me, and I'm hoping that sharing those might help all of you as well. Mr. So said that you're all welcome to shoot him a separate email or call him directly with any questions. He answered the first time I called, and patiently answered each of my questions which I greatly appreciated! Mr. So - please chime in if I've incorrectly stated or interpreted anything from our conversation:

- Meagan had already sent the ICS 214 to document activities and the 214v to document vehicle use - thank you!
- On the 214v, although they would prefer that we enter a separate form for each day with all vehicles, Mr. So said that we could submit a form that documents it for each week rather than for each day. And, we just need to document starting and ending mileage, not times.
- In our Tuesday meeting, I'd asked where we document equipment used and there wasn't a firm answer. Mr. So said that we need to use ICS 218, so I've attached that. And, he said that although a document for each day is preferred, that we could do weekly like with the vehicles. This will be hours used instead of mileage, obviously.
- He confirmed that submitting a spreadsheet of payroll documentation, plus any payroll reporting documents will be the way to track those expenses rather than having a specific ICS form. I'm personally doing a spreadsheet with each employee's name, hours worked for each day, and their pay rate + attaching our Quickbooks payroll report. As previously discussed, regular hours worked for any of our staff are not applicable here - only overtime or call-ins.
- For expenses incurred, a spreadsheet is also the way to document this, rather than an ICS form. He prefers us to split into categories such as food, small engines, etc. And then, we also need to have copies of all corresponding receipts included.
- For equipment losses, those will also be tracked on a spreadsheet rather than an ICS form. We need to submit with our insurance first, and then include any documentation that insurance provides on denials, total amounts covered, etc. to show what the gap is - and the gap in what insurance doesn't cover is what we can then submit to FEMA.
