Dear Representatives Kelly and DeFazio:

We are writing to thank you for introducing the "Investing in America: Unlocking the Harbor Maintenance Trust Fund Act". This legislation is critically important to the future of our ports and harbors

Our ports and harbors have long been underfunded. Provisions in the *Water Resources Reform and Development Act (WRRDA) of 2014* and the *Water Infrastructure Improvements for the Nation (WIIN) Act of 2016* have led to an increase in the amount of Harbor Maintenance Tax (HMT) revenue available for U.S. Army Corps of Engineers (USACE) operations and maintenance (O&M) activities around the country. Even with these provisions, however, the amount of money dedicated to dredging and jetty maintenance continues to fall short of what is needed to keep our ports and harbors competitive.

By taking the Harbor Maintenance Trust Fund (HMTF) off budget, your legislation will ensure that HMT revenue collected each year is actually spent at our nation's ports and harbors, rather than being used for deficit reduction. In turn, this will allow our ports and harbors to continue supporting the activities of Federal agencies, such as the U.S. Coast Guard, while also playing a key role in maintaining and creating jobs, and supporting fishing fleets, marinas and recreational facilities.

By introducing this legislation, you recognize the important contributions that our ports and harbors make to the economic well-being of our local communities, and to the broader U.S. economy. We appreciate your continued support.
